# Minutes of the General Meeting held at Neuadd Talgai, Llandygai On Thursday, 14 March, 2019 at 1900

#### 1. PRESENT:

All present were welcomed to the meeting by the Chair, Cllr. Evan Jones.

**2. Apologies** from Cllrs. Myfanwy Jones, Alun Thomas and Kevin Williams.

#### 3. Minutes

The minutes from the last meeting held on the 14 February, 2019 were agreed and deemed correct.

#### 4. Matters arising from the minutes

**The Old A55** – problems with cars speeding along this 30mph road. The PCSO from the Bangor station will be monitoring the situation as soon as possible.

**Eglwys Llan** –The trees have been cut, and the site looks tidy. The Clerk to send a thank you letter to Father John Matthews.

**Crymlyn, Aber -** large lorry travelling along the road has caused damage to the cottage and was stuck there overnight. The road still needs clearing and the wall of the cottage needs repairing. The Clerk to request an update on the wall and on the signage. Large yellow signs have been located at inconvenient places in the area. It was agreed that this Clerk will contact Welsh Government and Gwynedd Council to question why they had not consulted with the Council regarding these signs and where to locate them.

**Lôn Goed** – the ditch along the road needs clearing. Gwynedd Council have confirmed that they will arrange a site visit and will raise an order for the necessary work. The work has not been completed yet. It was noted that the road also needs sweeping,

especially the passing bays. Gwynedd Council notified the Council on the 13 March that the works were about to start.

**Airfields of Britain ConservationTrust** – the rememberance plaque has been installed. An event with the local schools to celebrate the plaque will be arranged in the Spring. Cllr. Megan Tomos has agreed to contact Ysgol Llanllechid, to give the pupils some time to do some research before the site visit.

**Allt Ty'n Hendre** – hole in the wall, on the right hand side on the way down. The clerk to notify Penrhyn Estate.

**Road near Wern Bach** – a pothole has appeared along this road once again. The Clerk to notify Cyngor Gwynedd.

**Grazing rights** – application received from I Hughes Morris. More information required.

**Defibrillator** – it was decided that the Community Council will consult with the community whether they have any ideas of any suitable locations. The Clerk to post on Partneriaeth Ogwen's facebook page.

**Kissing gates –** was reported that two new gates are required on footpaths in Llan. The Clerk to ask Gwynedd Council for new ones. No response received yet.

**Pavement from Tal y bont to 'Gypsy Corner'** – large amount of leaves on the pavement. The Clerk to notify Gwynedd Council. Some of the pavement had been cleared previously, the work has now been completed.

**Public Transport Review** – Cllr. Dafydd Meurig will make enquiries in to how to measure the bus journeys that are no longer running. A response was received from Gwynedd Council stating that they only assess the contarcts they contribute towards. They also noted that they were holding open days, with one held in Bethesda and in Bangor. At that stage, they will consider which services the residents require. Talybont and Llanllechid are down for consideration when they look at the whole network.

**Parc Main** – footpath from Llwyn Penddu to Bryn Eithin – the wooden bridge has collapsed, therefore the footpath can't be used. No response received from Gwynedd Council.

**Public Footpath at Tan y Garth** – underground drain has collapsed in one of the fileds, which onstructs the public footpath. No response received from Cyngor Gwynedd.

**Lon Ddŵr** – large potholes on the road leading up to The Slate. The Clerk has notified Gwynedd Council.

**Finance** – it was agreed that the Chairman and two other members will meet to discuss expenditure. The Clerk to revise the members of the Finance Sub-committee.
