# All were welcomed to the meeting by the Chair, Cllr. Geraint Hughes.

2. Apologies from Cllrs. Myfanwy Jones and Evan Jones.

# 3. Minutes

The minutes from the last meeting held on the 11 July 2019 were agreed and deemed correct.

# 4. Matters arising from the minutes

**Defibrillator** – It was reported that the Chapel Committee was satisfied with the proposed location of the equipment on the wall behind the chapel, at Bro Emrys. It was therefore decided that the Clerk will order the defibrillator. No response received from BT yet on the adoption of the kiosk at Llanllechid.

**Crymlyn, Aber -** a problem with a large lorry that came down the road and caused damage to the cottage and being stuck there overnight. The Clerk to request for the 'sat nav' signs again. A response received that the signs should be installed in the next 2-3 weeks.

**Airfields of Britain ConservationTrust** - The commemorative plaque has been installed. Cllr. Megan Tomos has contacted Ysgol Llanllechid regarding preparatory work with school prior to a visit, but no response so far.

**Ty'n Hendre Hill** – Hole in the wall on the right hand side on the way down. The hole has now been fixed.

**Road near Wern Bach** – A hole has emerged on the road again. Clerk to notify Gwynedd Council. Cllr. Dafydd Meurig to make enquiries too.

**Public Footpath near Tan y Garth** – an underground drain has collapsed in one of the fields on a public footpath. Gwynedd Council has been to carry out an inspection of the site, bu no apparent defect to the drain. This drain will require further examination. **Tan Lôn Flooding–** Gwynedd Council has been out to inspect the site. The work will be completed when resources become available.

**Tal y bont Playing Fiels –** confirmation of bench condition required.

**Drains on Lon y Bryn** – 4 sinks have lifted. The Clerk to notify Gwynedd Council. **Mountain to Parc Main** – sheep going through to the mountain as there is no barrier there. Clerk to notify Penrhyn estate. No response so far.

**Lôn y Bryn** – a pipe was blocked. It was reported that the pipe has been unblocked and cleaned.

**Lôn Bronydd** – work has been completed on the potholes, however the work has not been completed to a satisfactory standard. It was explained that this was only temporary, and that the work was on the Council's work programme.

**Community Energy** – Cllr. Geraint Hughes is keen to have a session on the subject in the Vestry, perhaps in September.
