**Airfields of Britain Conservation Trust** – the rememberance plaque has been installed. Cllr. Megan Tomos has contacted Llanllechid school regarding a possible research site visit, however not recieved a reply yet.

**Public Footpath, Tan y Garth** – an underground drain has collapsed in one of the fields on a public footpath. Gwynedd Council has been to carry out an inspection of the site, but no apparent defect to the drain. This drain will require further examination. Cllr. Dafydd Meurig will request an update on the matter.

**Tan Lôn Flooding-** Gwynedd Council has been out to inspect the site. The work will be completed when resources become available.

**Drains on Lon y Bryn -** 4 sinks have lifted. The Clerk to notify Gwynedd Council. **Mountain to Parc Main** – sheep going through to the mountain as there is no barrier there. Clerk to notify Penrhyn estate.

**Community Energy** – Cllr. Geraint Hughes is keen to have a session on the subject in the Vestry. It was confirmed that Huw Davies from Dyffryn Gwyrdd will be attending the next meeting.
