## 3. Huw Davies, Cyd Ynni/Dyffryn Gwyrdd

#### 5. Matters arising from the Minutes

**Crymlyn, Aber -** problem with a large lorry travelling along the road and causing damage to the cottage, and being stuck there overnight. The Clerk to make enquiries again regarding Sat Nav signs. It was reported that Gwynedd Council will be visiting the site this week..

**Airfields of Britain ConservationTrust** - the rememberance plaque has been installed. Cllr. Megan Tomos has contacted Llanllechid school regarding a possible

**Tan y Garth, Public Footpath** – an undergorund drain has collapsed in one of the fields on a public foootpath. Gwynedd Council has been to carry out an inspection of the site, but no apparent defect to the drain. It was agreed that Gwynedd Council will be making further investigations when the weather is suitable.

**Tan Lôn Flooding –** Gwynedd Council has been out to inspect the site. The work will be completed when resources become available. The Clerk to request an update.
